ORDBR:

In the reference read above, Government have issued orders discontinuing the temporary posts of Technical Assistants, Pharmacists and Dressers in Government ITIs, basing on the implementation Committee report.

Accordingly 224 posts of Technical Assistants, 20 Posts of Pharmacists and 39 Posts of Dressers under Non Plan (Temporary) and Plan (Temporary) existing in Government ITIs are discontinued w.e.f 1-3-2003. The details of posts discontinued ITI wise is furnished in Annexure. I.

Further, in view of discontinuation of the above posts, some of the staff who are working against Non Plan (Terrorry) and Plan (Temporary) have dither been adjusted against permanent posts in the Institute or transferred to nearby Institute which is enclosed in Annexure. II.

However, the staff who were transferred to other Institutes will continue to work in their present Institutions on deputation basis till the re-organisation of the posts are made. The salary of the persons who are transferred to other Institutes well be drawn and paid by the Principals where the person is transfered.

Filling up of the above discontinued posts will be viewed as violation of Government orders and are liable for serious disciplinary action against the concerned.

Any discrepency in the vacancy position is noticed the same may be informed to the Directorate immediately.

The Heads of Institutions are requested to inform the discontinuation of the posts to be concerned District Collectors.

The above orders should be complied with and should submit compliance by return of post.
